

ORDINANCE NO. 005, SERIES 2021

**AN ORDINANCE AMENDING CHAPTER 10.36.020/
NO PARKING AT SPECIFIED TIMES
OF THE GRAFTON MUNICIPAL CODE**

The Village Board of the Village of Grafton does hereby ordain as follows:

Part I. Chapter 10.36.020 is hereby amended as follows:

§ 10.36.020 **No parking at specified times.**

No vehicle shall be parked in any of the following areas at the times specified:



Tenth Avenue	West	7:00 a.m. to 4:00 p.m., except weekends and holidays	Between Power Street and Hickory Street
Eleventh Avenue [Amended by Ord. No. 026, Series 1999; Ord. No. 005, Series 2005]	West	7:00 a.m. to 4:00 p.m., regular school days	2-hour parking, from the south curblineline of Broad Street to a point 270 feet south No parking/bus loading: remaining 250 feet
Eleventh Avenue [Amended by Ord. No. 026, Series 1999]	East	7:00 a.m. to 4:00 p.m., regular school days	2-hour parking, from the south curblineline of Broad Street to a point 375 feet south No parking: remaining 120 feet
Beech Street [Amended by Ord. No. 026, Series 2005]	North	2:00 a.m. to 5:00 p.m.	From Eleventh Avenue to a point 235 feet west
Bridge Street	North	7:00 a.m. to 5:00 p.m., except weekends and holidays	From 125 feet west of Eleventh Avenue to 165 feet west of Eleventh Avenue
Bridge Street	North	7:00 a.m. to 5:00 p.m., Monday through Friday	From 6 th Avenue 100 feet west

Street	Side	Time Period	Limits
Bridge Street	South	7:00 a.m. to 5:00 p.m., Monday through Friday	From 6th Avenue 100 feet west
Bridge Street	South	7:00 a.m. to 11:00 a.m., Monday through Friday	First four (4) parking spaces along the south side of Bridge Street, directly adjacent to the establishment located at 1305 Wisconsin Avenue
Cheyenne Court [Amended by Ord. No. 018, Series 2010]	South	6:00 a.m. to 4:00 p.m. Monday through Friday	From the Grafton School District property to Cheyenne Avenue
Washington Street		7:00 a.m. to 5:00 p.m., regular school days	From Seventh Avenue to a point 1,934 feet east
Washington Street	South	7:00 a.m. to 5:00 p.m., regular school days	Between Sixth Avenue and Eighth Avenue

Part II. Severability. If any provision of this ordinance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions of this ordinance.

This ordinance shall take effect upon passage and posting.
